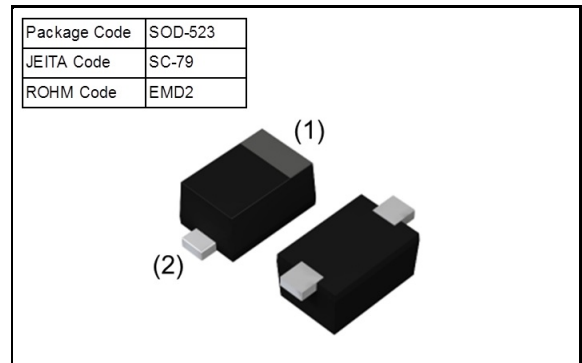

Attention

Compared with PN junction diodes, Schottky Barrier Diode is generally high reverse current (I_R). The reverse loss of the diode might increase as temperature increasing that causes heat-up and further I_R . This phenomenon might end up the thermal destruction (thermal runaway). 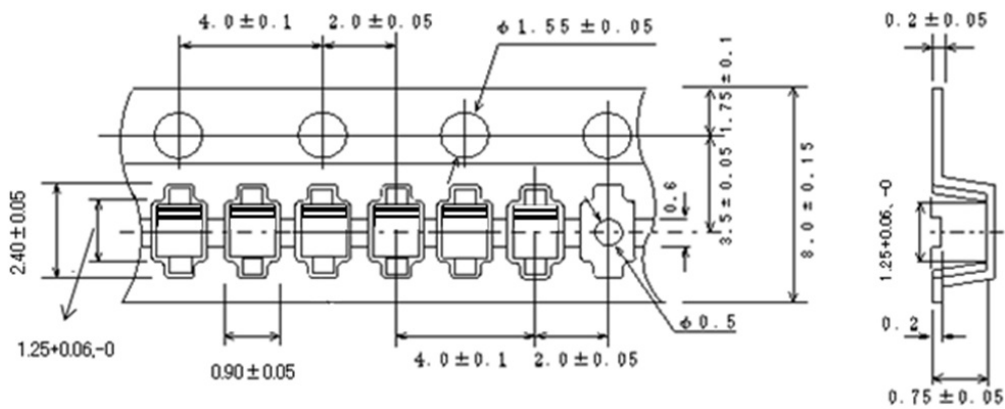
